Cooking oil can be recycled to make biodiesel, an alternative fuel source. The ECC and Crud Cruiser accept used cooking oil year round.

## Paint the environment green

Proper disposal of paint can be confusing.

No paint in liquid form should ever be placed in a trash container, recycling bin or dumped into a storm drain.

Latex (water-based) paint can be dried up with an absorbent material such as kitty litter, newspaper or sawdust and then put in the regular trash. Completely empty paint cans may be recycled.



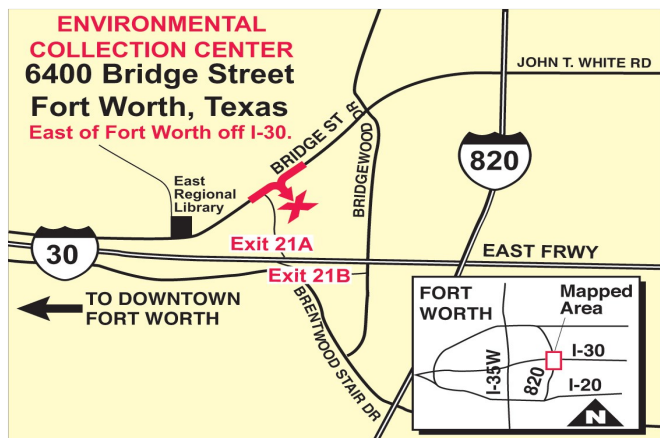
Any leftover latex paint and all other painting products (oil-based paint, turpentine, solvents, varnishes, stains, etc.) should be disposed of as household hazardous waste at the Environmental Collection Center (6400 Bridge St.). Paint is recycled and shipped to an energy-from-waste facility that utilizes it in the production of electricity.

The best solution is not to have leftover paint. Buy the proper amount. Use it up on small jobs or touch ups. Share it with relatives, neighbors, schools or charities. Residents can even get free paint from the ECC's Help Yourself Shelf for those odd jobs that don't require a specific color.
