## Rules and Requests for a

### “PAW”tastic, “PAW”awesome, Tail wagging time!!

We have a few rules for everyone to follow to ensure a fun time. Our staff is present to prevent accidents, not to supervise children/dogs, so please closely supervise your children/dogs. Remember this is a “DOG” event. Both dogs and children frighten and excite easily and react differently so stay alert. We thank you in advance!

### **Rules** for our four legged friends and those who love them:

1. All dogs must **be current with their rabies vaccinations** and have current tags displayed.
2. All **dog handlers need to be 18 or over**. Dog owners are liable for damage or injury inflicted by their dog(s).
3. Monitor your dog(s) behavior and remove them if they are exhibiting aggressive behavior.
4. For better control and to reduce tripping hazards, **no retractable leashes please**.
5. Please do not bring dogs in season...it’s not that kind of party!
6. Please practice good *PETIQUETTE* and pick up any “deposits” that your pet leaves.
7. Puppies less than 6 months old will have to wait until next year☺ (too young to be vaccinated).
8. Do not assume your dog(s) love to swim, and do not force your dog(s) into the water, you wouldn’t like to be forced either.

### **Requests** from your dog:

1. Please make sure to bring my bowl so I can have a refreshing drink of water.
2. Don’t overdo it with me, I will let you know when I have had enough.
3. Play with me, have fun with me, get in the water with me, you need exercise too.
4. Don’t bring my favorite toy, I do not wish to share it with other dogs.
5. Don’t get distracted talking or looking at other dogs, you know I am the cutest and smartest.
6. Bring your camera, as I mentioned in #5, I am the cutest!

## ATTENDEE WAIVER AND AGREEMENT

### I AGREE TO THE FOLLOWING TERMS

**\*\* Limit 2 dogs per family \*\***

**\*\*All dogs need to be actively supervised, by a person 18 years of age or older\*\***

- (4) I agree that if my dog(s) exhibit any aggressive behavior towards other dogs or people, I will be asked to leave.
- (5) I agree to be a responsible pet owner by picking up any trash or dog waste my pet generates.
- (6) I release any right and grant full permission to the **City of Saginaw** to use, without payment any photographs, videotapes, motion pictures, sound recordings or any other record or information derived from this or any other **City of Saginaw "Puppy Pool Party"** related event.
- (7) In participating in the "Puppy Pool Party" event at the **Saginaw Aquatic Center**. I recognize and acknowledge that injury, illness or damage could occur to my person, children, property or pet(s) caused by any of the participating pets, participants, premises or property defects or other causes. Nonetheless, in consideration of the acceptance of this entry and the allowance of myself, my dog(s) and/or my children's participation in the **Saginaw Aquatic Center "Puppy Pool Party"**, I for myself and my children and all others who might otherwise make claim on behalf of me or my children, do hereby voluntarily assume full and sole responsibility for any injury, illness or damage, accidental or intentional, which may occur to myself, my children, property or pets directly or indirectly as a result of or during my or my children's participation in the **Saginaw Aquatic Center "Puppy Pool Party"**.
